ARx Affix is an additive that improves coverage on the intended object by reducing the percentage of fine droplets in a spray solution.

DIRECTIONS FOR USE:

Consult an agronomy professional or pesticide application label for specific use rate and application instructions.* Always read the herbicide label and product websites for most up-to-date approval of tank mix adjuvants. Always check compatibility with other products prior to use.

USE RATE:

4-6 oz per acre; ARx Affix will generally be added at the end of the tank mix procedure.

GENERAL INFORMATION

ARx AFFIX™ is a drift and deposition aid that improves coverage on the intended target by reducing the amount of fine droplets in a spray that are susceptible to drift or evaporation. AFFIXTM does not substantially increase coarse droplets, allowing it to optimize deposition and coverage, enhancing pesticide performance. **AFFIX**^{†M} functions by ground and by air.

Always use AFFIX™ with appropriate nozzle choice, boom height, and pressure for optimal drift reduction.

DIRECTIONS FOR USE

For use with Herbicides (including desiccants), Insecticides and Fungicides:

Prior to use, read all directions on this label. **Drift Reduction:**

To reduce drift, add AFFIX™ at a rate of 4-6 oz/A in solutions of 5 to 25 GPA. For >25 GPA. use 8-10 oz/A. Do not exceed 1% of finished spray volume. The higher use rate is recommended when spraying at high pressure and in higher GPA solutions. Before mixing pesticides with AFFIX™, conduct a jar test to determine compatibility. Deposition Aid: To enhance deposition only, with insecticides or fungicides, use 2 to 4 oz/A in solutions of

Aquatic Use: AFFIX™ can be used for aquatic applications including surface water at a rate of 4 to 6 oz/A. Do not exceed 6 oz/A. Always follow tank mix product labels for specific directions and precautions.

MIXING INSTRUCTIONS

SHAKE WELL OR RECIRCULATE BEFORE USE

Add **AFFIX™** after pesticides or other adjuvants are added but prior to complete filling of the spray tank. For Direct Injection: AFFIX™ can be applied through injection systems where AFFIX™ is added to one of the system's chemical injection tanks. An in-line mixing chamber is recommended.

- Step 1 Add AFFIX[™] to the chemical injection tank. Step 2 Pump the correct amount of **AFFIX™** into the line.
- Step 3 Pump the proper amount of water, pesticide, and other adjuvants into the line for mixing with AFFIX™ and chemicals before going into the spray boom.

Do not mix **AFFIX**TM with other undiluted adjuvants in an induction system or container. Once mixed in water, **AFFIX™** is compatible with most other adjuvants in any mixing order.

MAINTAIN AGITATION AT ALL TIMES UNTIL THE CONTENTS OF THE TANK ARE SPRAYED OUT.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food or feed by storage, disposal or cleaning of equipment.

STORAGE: Store in original container only and keep sealed. Store in closed storage areas.

ADJUVANT DISPOSAL: Wastes resulting from the use of this product may be disposed of through on-site spray application or at an approved waste disposal facility.

CONTAINER DISPOSAL: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
